

Rewards Dining Club December 5, 12, 19, 26 OFFICIAL RULES

HOW TO PARTICIPATE:

- 1. Must be a 24K Select Club Member to participate.
- 2. Guests must earn 300 tier points between the hours of 8am 4pm on promotional Tuesdays to be eligible for a voucher.
- 3. All guests must locate the rewards kiosk to print their vouchers between 8am 4pm Tuesdays in December.
- 4. All guests must present their voucher, ID and 24K Select Club Card to the outlet listed on the voucher to redeem until 6 days from issuance and MUST be redeemed by Monday at 11:59PM prior to the next promotional Tuesday.

PROMOTION DETAILS:

- 1. Must be a 24K Select Club Member to participate.
- 2. All guests must visit a Promotional Kiosk 8am 4pm Tuesdays in December to receive a \$15 food & beverage voucher for Alpine Union.
